I am a gender and development researcher and consultant with over 20 years' experience and a Ph.D. in Social Anthropology (with a focus on gender and development) from SOAS, London University.

The former head of BRIDGE, a globally-respected gender and development research programme based at the Institute of Development Studies, I have a track record of leading innovative research and knowledge programmes and of writing and disseminating ground-breaking policy-oriented publications and developing training materials aimed at supporting development policy-makers and practitioners to integrate gender and equality across their work, as well as generating knowledge on a range of gender-specific issues.
